Historical Note

This oral history project was a broad based program undertaken to collect oral histories that would reflect and add to the library's local history resources. The audio portion of the collection contains interviews of people from the greater Hudson area collected by participants in the library's 2013 oral history workshop offered in collaboration with Oral History Summer School (OHSS), as well as by OHSS staff and alum contracted by the library to collect life stories of community members. Oral histories continue to be collected both by the Hudson Area Library staff.

The interviews were conducted by Melinda Braathen, John Craig, Jenny Goldberg, Inge Lincoln, Alanna Medlock, Maija Reed, Suzanne Snider, Katharine Umsted, and Robyn Waters.

Scope and Content Note

The HAL Oral History Project collection consists of digital summaries and audio recordings conducted by various individuals with residents of the City of Hudson, N.Y from April 2013 to 2020. The interviewees were Dorothy and Ralph Avery; Leo Bower; John Brodowski; Carmine Ciancetta; Rich Conaty; Joseph D'Onofrio; Mary Hallenbeck; Norma Hart; Suzanna Koski-Cincotti; Arthur Koweek; Kathryn McDonald; Hazel Murray; Nguyen Tasha; Carolyn Russo; Art Smith; Viola Williams. In order to build a profile of social and community life for people growing up, coming into or living in the city, interview topics covered included education, religion, family life, community relations, pre-immigration experiences, WWII, neighborhood living conditions, and memories of Hudson Armory.

Avery, Dorothy	In this oral history, Avery discusses her family genealogy, her marriage and children, her work and her involvement in the local Hendrick Hudson Daughters of the American Revolution (DAR) Chapter and the Hudson Fortnightly Club. She relates other local history stories.	Born in Albany in 1927, she is a longtime resident of Columbia County.
Avery, Ralph	In this oral history, Avery discusses his life as a child in Hudson, his D-Day experience, his work career at Lone Star Cement and other local businesses, and his involvement in the Sons of the American Revolution.	Born in Hudson in 1924, he lives with his wife Dorothy in Claverack.
Bower, Leo	In this oral history, Bower describes his life in lower Hudson, his time with his father in Shantytown and his work career. He relates many stories from his life in Hudson.	Bower grew up in Hudson and spent a great deal of time in Shantytown with his father shad fishing and socializing with the people who had shacks there.
Brodowski, John	In this oral history, Brodowski describes his life in lower Hudson, an enclave of Polish immigrants, his schooling, his time in the Army during which he participated in the Normandy Invasion, his marriage and life upon his return to Hudson	Born in Hudson of Polish immigrants, John started his own print shop in Hudson: Johnny's Ideal Printing.
Ciancetta, Carmine	Ciancetta relates his childhood spending time at the river and seeing the Hudson Day Lines and the steam engine trains. He describes businesses and memorable events in Hudson such as the Evans Brewery and St Mary's School fires.	Born in Hudson, Carmine took over Rowles Studio and continued the photography business into the 1980s.

Conaty, Rich	Conaty moved to Hudson in 1998 and founded a radio program, "The Big Broadcast". He also describes his work driving for COARC.	Born in NYC in 1954, he moved to Hudson in 1998, he previously worked at ABC News and various radio stations.
D'Onofrio, Joseph	In this oral history, D'Onofrio discusses his family, who have Italian and Lithuanian origins, and life in Hudson. As a researcher of local history, D'Onofrio is able to discuss details about many families, businesses, and memorable events.	Born in Hudson in 1942, D'Onofrio worked at the Universal Match Company and the Department of Social Services.
Hallenbeck, Mary	In this oral history, Hallenbeck recounts her family and childhood, her work at Columbia Memorial Hospital, and her involvement with the Hudson Historic Preservation Commission and the organizations Historic Hudson.	Born in Claverack in 1930, Hallenbeck trained in nursing at n various locations including Bellevue Hospital for pediatrics.
Hart, Norma	In this oral history, Hart discusses her move from NYC as a child, her childhood and family, and her work at the Hudson Area Library.	Born in NYC, Hallenbeck grew up near Hudson. She attended Hudson High School. Later, after working in NYC as an adult, she then returned to the Columbia County area.
Koski-Cincotti, Suzanna	Koski-Cincotti moved to Hudson 20 years prior to this oral history. She lived down South until she and her husband moved to NYC. Koski-Cincotta details her work for United Cerebral Palsy of Albany and her time as a special education teacher. She discusses her children and their education in private religious schools and her involvement with local churches and synagogues. She also focuses on the changes in Hudson in the last 20 years and the state of the public education system.	Born In Mississippi, Koski-Cincotti grew up in the South, moved to NYC with her husband, then relocated with her family to Hudson.
Koweek, Arthur	In this oral history, Koweek details his family's time in NYC and Red Hook before moving to Hudson. He describes Hudson in the 1950s and his time working at the Urban Renewal Agency. He also describes his marriage and children and the toy store he and his wife ran, The Town Fair, on Warren Street.	Born in NYC, Koweek headed urban renewal in Hudson under Mayor John Kelly.

McDonald, Kathryn	In this oral history, McDonald was born in Hudson and lived at Fountain Head as a child. She describes her father's ice cream parlor on Front Street and the Fountain Head Hotel and property. She discusses her involvement with the Greenport Historical Society and details stories of the area and Hudson specifically.	Born in Hudson, McDonald was involved with the Greenport Historical Society.
Murray, Hazel	Murray came to Hudson from South Carolina and worked at the New York Training School for Girls. In this oral history, she also discusses her catering business and her involvement in Shiloh Baptist Church.	Born in South Carolina, Murray had lived in Hudson for 60 years at the time of the interview. She worked in the New York Training School for Girls and was involved in the Shiloh Baptist Church.
Nguyen, Tasha	Nguyen was born in Hudson and has lived there all of her 21 years. She speaks of the changes in the city with antique stores, homes being renovated but also more violence and problems.	Born in Hudson and lives in the city with her two year old daughter, Nguyen enjoys drawing.
Russo, Carolyn	Russo lived in Hudson all her life and discussed the Italian-Polish neighborhood she grew up in, the bar scene and red light district, community events, and her volunteer work for the Hudson Area Library.	Born in Hudson and worked at IBM in Kingston and reflected on the impact it had when it closed.
Smith, Arthur (Art)	In this oral history, Smith recalls how his father worked for the Gifford-Wood Company and the Atlas Cement Co. His mother worked at the thermal mills. Smith talks about going to the Playhouse Vaudeville theater, playing near the river, getting scarlet fever, and the changes in Hudson through the years.	Smith was born and grew up in Hudson and now lives in Kinderhook. He joined the Navy, worked mainly for [Niagara Mohawk] Power Company and became a Mason.
Williams, Viola	Williams recounts her time growing up in Stockport around WW2, talks about a smallpox outbreak and quarantine in 1900, and her ownership of several historical properties in Stockport, including a home built by Capt Seth Macy in 1816. She also speaks about the paper mills in the area.	Williams is the Stockport Town Historian and has lived there much of her life. She worked at a confectionery store on Third Street, as a seamstress in Philmont and at the A & P.
